RULES AND REGULATIONS

The following is a brief summary of the Document Rules & Regulations of the Association. The comprehensive list of rules and regulations can be found in the governing documents online:

Pet related, article XI, section 3.C, "...all dogs and cats must be accompanied by an attendant... which leash shall not exceed eight feet in length. No cat or dog shall be permitted to run at large outside of the unit."

Landscaping related, article VI, section 2, "...if any of the forgoing landscaping requires replacement, it shall be the responsibility of, and at the expense of, the Owner of the applicable Unit to make such replacement."

Renting related, article XII, section 6.b.2,"...the Association, as agent for the landlord/Owner, has the power to evict the tenants and occupants under Chapter 83, FS, for violations of the Governing Documents and reasonable rules and regulations, as amended form time to time."

Exterior changes related, article IX, section 1, "No building, outbuilding, garage, fence, wall, retaining wall, or other structure fo any kind shall be erected, constructed, placed or maintained on the Properties, nor shall any dwelling or other Improvements on each Unit, as originally constructed...be altered, changed, or modified unless...first submitted in writing for approval and approved in writing by an Architectural Committee."

Enforcement related, article XII, section 1, "The Association... shall have the right to enforce, by any proceeding at law or in equity, all restrictions, conditions, covenants, reservations liens and charges now or hereafter imposed by the provisions of this declaration. In any such suit the prevailing party shall also be entitled to recovery of all costs and expenses including court costs and attorney's fees."

Parking Policy

- Parking on the street or the clubhouse parking lot is prohibited between 2am & 6am. Vehicles may be towed.
- Vehicles subject to towing will be issued two warnings before being towed on the third incident.
- Commercial vehicles with or without signage are prohibited unless parking inside an enclosed garage.
- Vehicles with signage are prohibited unless parked inside an enclosed garage.
- Parking on the swale, common grass area or sidewalk is prohibited.
