REQUEST FOR ARCHITECTURAL APPROVAL - SIENA OAKS

Dear Homeowner,

The documents of our Homeowner Association require your application for approval of <u>all</u> changes on the exterior of your unit or lot. The purpose of this requirement is to protect the quality of life and the property value within our community.

WHO MUST APPLY:

Every Owner planning any improvement on any lot including but not limited to: Houses, fences, swimming pools, screen patios, gazebos, decks, driveways, basketball equipment, awnings, hurricane shutters, windows, generators, solar panels, satellite dishes, painting, roof replacement and all landscaping changes.

MEETING DATE:

The Architectural Control Committee (ACC) meeting is held the Monday prior to the regularly scheduled meeting of the Board of Directors. The Board of Directors meets the second Thursday of each month. Applications must be submitted 5 days prior to the meeting of the ACC to be considered.

APPROVALS / DISAPPROVALS:

A decision regarding the approval status for most applications will be determined at the meeting of the ACC. Technically complex applications may take up to 30 days to review. Incomplete applications will be returned to the homeowner for completion and resubmission for the next ACC meeting.
