PRESIDENT'S MESSAGE

Dear Friends and Neighbors,

Summer has arrived and brought heat and rain. It's a good idea to review your hurricane emergency plans several times so you are prepared if the time comes. At the May Board meeting we reported:

- Improvements at the clubhouse and pool are continuing and should be completed very soon. Those improvements include: painting inside and outside of the clubhouse, resurfacing the pool deck and all walkways, resurfacing the pool (which is in the final stages). When the pool resurfacing is completed, we hope to return to night swimming as the lighting in and around the pool will be upgraded.
- Some minor improvements still to be done include painting the concrete tables around the pool and

replacement of the outside patio fans.

- The two HOA community parking lots will be closed for a few days in June for recoating. Be prepared with alternative parking plans.
- The Board approved CRIZ to update our property appraisal which is done every three years.


TUESDAY, JUNE 25 AT 5:00 P.M. THROUGH FRIDAY, JUNE 28 AT 5:00 P.M.

Any vehicle not removed by the start date will be towed. If you need extra parking, our HOA has received permission to park, on a temporary basis, on the Forest Oak Golf Course lot immediately next to the tennis courts. **Only use the lot closest to the tennis courts.** All vehicles **MUST** have a placard on the driver's side dash that can be easily read with your: Name, Address, and Phone Number. Any vehicle parked on the Forest Oak Golf Course lot without this information or at the wrong spot could be towed at the owner's expense. Animal Waste Pickup

Did you know, as of 1991, dog waste is considered a nonpoint source pollutant by the Environmental Protection Agency, which puts it in the same category as herbicides and insecticides? Did you know unattended waste can harm your health? Did you know ringworms, roundworm, salmonella and giardia are some of the bacteria found in dog waste? Did you know a roundworm can remain infectious in contaminated soil or water for years?

All pet owners have an important responsibility to keep pet waste off the grounds in our neighborhood. The Palm Beach County Animal Care and Control Ordinance for Animal Waste states the following (Ordinance No. 98-22, Section 4-9):

• The owner of every dog and cat shall be responsible for the removal of any feces deposited by his/her animal on public property, public walks, public beaches, recreation areas or <u>private property of others</u>.

Please remember to clean up after your dog which provides a cleaner, safer place for us all to live.



Leashes

Lucerne Lakes rules and regulations stipulate that dog owners must have their dog under restraint or be controlled by a person by means of a chain, leash or other device if the dog is off its owner's property. Please take heed when walking Fido.

CURBSIDE GARBAGE, YARD WASTE AND BULK COLLECTION WILL CHANGE ON OCTOBER 1, 2019

As The Palm Beach County Solid Waste Authority explains: **GARBAGE- Every residential curbside customer will receive a new garbage cart that will be delivered to your home, most likely in the months of August and September. Please DO NOT use the cart until October 1st when the new service starts. On October 1st, all garbage must be placed inside the new cart. You will be able to purchase a second cart, if you need one, for a one-time fee of \$65. There will be no additional collection or disposal charges for the additional cart. Your hauler will be responsible for the repair/replacement of the cart. Garbage will still be collected twice a week.

****BULK SERVICE** – Bulk collection like appliances, furniture, and large household items that do not fit in your cart will be provided one day per week and limited to no more than three items. If you have more than the allowed three items, contact SWA Customer Service at 561-697-2700 for an estimate to have the additional items removed.

****YARD WASTE** – If your yard waste pile exceeds 6 cubic yards, the yard waste will not be picked up. The pile will be tagged and will be the responsibility of the resident to arrange for pickup for an extra fee. Debris other than palm fronds and tree branches, such as leaves, tree and hedge trimmings, pine needles, etc., must be containerized. The tree branches and palm fronds should be neatly stacked in a pile that does not exceed 6 cubic yards. Branches should

be cut into pieces that are no more than 6 feet long, 6 inches in diameter, and weigh no more than 50 pounds each. Palm fronds can be any length.
