#### DO YOU RENT YOUR RESIDENCE OR ARE YOU A RENTER?

If you are the owner of property in Lucerne Lakes, South (LLHOA), and <u>rent your residence</u>, you should be aware of the following: as stated in the Declaration of Covenants, Conditions, and Restrictions (CCR), which you signed when you purchased your property in Lucerne Lakes, South, there is an obligation to register with GRS, our Property Management Company (which oversees our Community).



As stated in the CCR:

Any unit that has a change of ownership after the recording of this document (the CCR) will not be allowed to rent the
subject property for a period of eighteen months. This restriction shall pertain to any owner who obtained title to the
Unit after this document (the CCR) was recorded through inheritance from a Last Will and Testament or a Family Trust
was legally recorded in the Books of Record of Palm Beach Court.

All renters must be registered with LLHOA to live in Lucerne Lakes, South. If you have not previously submitted an application and a copy of your lease, please download an application and submit the paperwork with the proper fees to the LLHOA. If your lease is older than one year, you must submit a renewal of your lease. The application form can be found on the GRS website: <a href="www.grsmgt.com/association/lucern-lakes/">www.grsmgt.com/association/lucern-lakes/</a>, navigate to the left side under "Downloads", and click on the "Purchase/Lease Application" button. #### Waste Authority Urges Proper Battery Recycling\*

Palm Beach County residents now can take all their harmful batteries to the same place: the Solid Waste Authority's Home Chemical and Recycling Centers. While regular alkaline batteries (AA, AAA, C, D, and 9-volt) can be placed in regular trash, any other type of battery (rechargeable, nickel-cadmium, automotive, lithium-ion, cellphone, lead-acid) requires special recycling. Improper disposal can hurt public health and the environment. Batteries can be properly recycled at the following Home Chemical and Recycling Centers: Jupiter, West Palm Beach, Belle Glade, Royal Palm Beach, Lantana, Delray Beach-West, Delray Beach-East.
