The services provided to you under the Association's agreement with ADT include:

- Burglar alarm monitoring
- Monitoring of security system connected life safety devices (smoke, heat and CO detectors)

We offer life-safety devices like monitored smoke and carbon monoxide detectors and motion, glass break and flood detectors for interior protection. Cellular communication is available so a phone line or voice over cable is not needed for system communication. Home automation and video services are also available.

ADT also offers a Quality Service Plan ("QSP") that covers service calls, parts and labor for normal wear and tear during normal business hours for only \$10.00 per month (plus tax) per month (some exclusions apply).

The Palm Beach County Sheriff's Office (PBSO) requires that all users of monitored alarm systems obtain a Burglar Alarm Permit. You may register online at https://alarms.pbso.org/. Once registered, PBSO will provide you with a User's Permit Number. Please provide ADT with your permit number when we activate your system OR call our customer care team at 800-878-7806 and ask to add it to your account. Failure to have a Burglar Alarm Permit may result in a non-response or fine from PBSO.

Once your connection to ADT Security is established, you may visit our secure website anytime to register your account allowing you to view your alarm activity, request a certificate of monitoring and update your contact information at www.MyADT.com.

We encourage you to regularly use and test your security system to protect your family, home and personal property. In addition to providing you with peace of mind, a monitored security system can save you up to 20% on your homeowner's insurance. Reach out to your insurance agent for details. Once your system is activated, call us at **800-878-7806** or register online at **www.MyADT.com** where you can download your Certificate of Monitoring immediately, then submit the certificate to your insurance agent for any available discounts.
