#### EXHIBIT "1"

AMENDMENT TO THE ARTICLES OF INCORPORATION OF THE WHITEHALL CONDOMINIUM OF THE VILLAGES OF PALM BEACH LAKES ASSOCIATION, INC.

Item 1. A new paragraph shall be added to Article IX(J) of the Articles of Incorporation, which shall provide as follows:

Notwithstanding anything to the contrary, in the event the Board of Directors shall determine that the number of Directorships of the succeeding year is three, then the Director receiving the most votes shall serve for two years and the other two shall serve for one year. In the event the Board of Directors shall determine that the number of Directorships for the succeeding year is five, then the two Directors receiving the most votes shall serve for two years and the other three shall serve for one year. Any tie shall be decided by a flip of the coin.
