## AMENDMENT TO THE BYLAWS OF WHITEHALL CONDOMINIUMS OF THE VILLAGES OF PALM BEACH LAKES ASSOCIATION, INC.

(additions indicated by underlining;
 deletions indicated by "---")

Article 7 of the Bylaws, Section 7.2(a), is hereby amended to read as follows:

7.2 (a) The Board shall adopt a Budget for the Common Expenses of the Association for each forthcoming fiscal year at a special meeting of the Board ("Budget Meeting") called for that purpose during the first two (2) weeks of November December of every calendar year. Prior to the Budget Meeting a proposed budget shall be prepared by or on behalf of the Board and shall include, but not be limited to, the following items, if applicable:

(i)	Administration of the Association
(ii)	Insurance and bonding fees
(iii)	Management fees
(iv)	Maintenance
(v)	Taxes upon Association property
(vi)	Taxes upon leased areas
1	Other simenes

(vii) Other expenses
(viii) Operating capital

(ix) Reserves

(x) Fees payable to the Division of Florida Land Sales and Condominiums

Copies of the proposed Budget prepared prior to the Budget Meeting and notice of the exact time and place of the Budget Meeting shall be mailed to each Member at the Member's last known address as reflected on the books and records of the Association on or before thirty (30) days prior to said Budget Meeting, and the Budget Meeting shall be open to the Membership. Copies of the adopted budget shall be mailed to each Member within 60 days of its adoption.
