AMENDMENTS TO THE BYLAWS OF WHITEHALL CONDONINIUMS OF THE VILLAGES OF PALM BEACH LAKES ASSOCIATION, INC.

(additions indicated by underlining; deletions indicated by "---")

 Article 3.11 of the Bylaws is hereby amended to read as follows:

No member shall be allowed to exercise his vote or serve as a Director unless he is current on all assessments. In addition, each Director shall be a unit owner at a Condominium located within Whitehall Condominiums of the Villages of Palm Beach Lakes Association, Inc.

2. Article 5.13 of the Bylaws is hereby amended to read as follows:

Entering any Apartment at a reasonable time and upon reasonable notice to make emergency repairs, to avoid waste or to do such work reasonably necessary for the proper maintenance operation of the Association.

Entering any unit or vehicle that has installed personal alarm systems. Alarms shall be defined as devices used for the detection of unauthorized entry, burglary, or any other criminal activity, which, when activated, emit a sound, signal, or message to alert others. Unmonitored alarms shall be prohibited. If such systems fail and become a nuisance to unic owners, the Association will take action to silence the alarm; and all cost and liability must be borne by the owners of such systems.
