Article XV.A.1 of the Declaration shall be amended as follows:

The responsibility of an Apartment Owner is as follows:

- 1. To maintain in good condition, to repair and to replace at the Owner's his expense all portions of the Owner's his Apartment and limited common elements appurtenant to the Apartment, including any screening on the Apartment's his Florida room, all window panes and all interior surfaces within or surrounding the his Apartment (such as the surfaces of the walls, ceilings and floors); to maintain and repair the fixtures therein, including the air conditioning equipment; and to pay for any utilities which are separately metered to the his Apartment.
- (a) Every Apartment Owner is responsible for the cleaning of the exterior of all window panes contained in their his Apartment and limited common elements appurtenant to the Apartment.
- (b) Every Apartment Owner must perform properly all maintenance and repair work within their his Apartment and limited common elements appurtenant to the Apartment, as aforesaid, which if not performed would affect the Condominium Property in its entirety or an Apartment belonging to another Apartment Owner.
- (c) Each Apartment Owner shall be expressly responsible for the damages and liabilities that the Owner's his failure to perform the his above mentioned responsibilities may engender.
- (d) Apartments Limited common elements appurtenant to Apartments (terrace/balcony) should be maintained kept in clean and neat condition. Repaired of the terrace/balcony railing and walls shall be the responsibility of the Association in accordance with the

building plans and specifications used by $\underline{\text{the}}$ Developer, copies of which are to be on file in the office of the Association, except for changes or alterations approved by the Board as provided in this Declaration.
