**FOURTH CERTIFICATE OF AMENDMENT TO THE
DECLARATIONS OF CONDOMINIUM OF
WHITEHALL CONDOMINIUMS OF THE VILLAGES OF PALM BEACH LAKES**

THE UNDERSIGNED CERTIFY that the Declarations of Condominium of Condominiums 1 through 20 of Whitehall Condominiums of the Villages of Palm Beach Lakes, recorded as set forth in Exhibit "A", have been amended as follows:

1) Article XII.D of the Declaration is amended as follows:

Except as provided under the Rules and Regulations promulgated by the Association from time to time, an Apartment Owner shall not keep any pet in an his Apartment, nor keep any other animals, livestock or poultry nor may any of the same be raised, bred or kept upon any portion of the Condominium Property. No clothesline or other similar devise shall be allowed in any portion of the Condominium Property. No trailer, boat, van, camper, truck, motorcycle, moped, motorized cycle, off-road vehicle, or commercial vehicle shall be permitted on any portion of the Condominium Property, except for trucks furnishing goods and services during the delayed hours and except as the Association may designate for such use if any such use is so designated by the Rules and Regulations.

2) Article XIV.A of the Declaration shall be amended as follows:

No Apartment Owner may dispose of an his Apartment or any interest therein by sale or lease without approval of the Board on behalf of the Association, which approval of the Association shall be obtained in manner hereinafter provided; however, no Apartment may be leased more than once in any twelve month period.

The language added is underlined; the language deleted is ~~struck out~~.

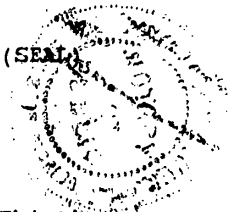
