THIS CERTIFICATE OF AMENDMENT TO THE AMENDED AND RESTATED DECLARATION OF RESTRICTIONS, RESERVATIONS AND COVENANTS OF CLOISTERS PROPERTY OWNERS ASSOCIATION, INC. is made this day of September 2014 by the President and Secretary of CLOISTERS PROPERTY OWNERS ASSOCIATION, INC. ("Association"), the homeowners association operating the Cloisters Development.

PROPOSED AMENDMENT TO THE DECLARATION OF COVENANTS AND RESTRICTIONS FOR THE CLOISTERS PROPERTY OWNERS ASSOCIATION, INC.

This proposed amendment amends the current Paragraph 8.9, Leasing of Units, adding a new Subparagraph E as follows:

E. No Unit may be leased during the first two (2) years of ownership, Guests may not occupy the unit during such time unless the owner is also occupying the unit.

All other provisions of Paragraph 8.9 shall remain as written and are not reprinted herein. Text which is neither included or deleted is as currently written. Text which is underlined is added. Text which is stricken out is deleted.
