As used herein the following shall apply:

- A. Words in the text are lined through with (----) indicate deletions from the present text.
- B. Words in the text which are <u>underlined</u> indicate additions to the present text.
- 1. Section 8.6 of the Amended and Restated Declaration shall be amended to read:
 - "8.6 Clothing and Similar Articles. No clothes or similar articles shall be allowed on the exterior portions of the Units, including patios. No clotheslines shall be permitted anywhere on the Properties. Nothing shall be hung, displayed or placed on the exterior walls, doors or windows of the Unit; except as may be permitted by Section 7 above and approved by the Architectural Control Committee under Section 7 above."
