- 1. Affiant is an attornex licensed to practice law in the State of Florida, and is a member of the law firm of KATZ, BARRON SQUITERO & FAUST, P.A.
- 2. Affiant has read and is familiar with the Declaration of Condominium of BOYNTON OASIS, a Condominium (the "Condominium"), dated February 29, 2000, recorded March 8, 2000, in Official Records Book 11647, Page 64, of the Public Records of Palm Beach County, Florida, as subsequently amended from time to time (the Declaration").
 - 3. The Condominium is located on land described as follows:

All of the Plat of "PARK LAKE HOMES, at INDIAN WELLS, a P.U.D., according to the Plat thereof, as recorded in Plat Book 82, Rage 50, of the Public Records of Palm Beach County, Florida.

- 4. The Condominium, when completed, will contain twelve (12) buildings, containing residential dwelling units, which total 78 units. As each building containing residential dwelling units is completed and issued a Certificate of Occupancy, an Amendment to the Declaration of Condominium is prepared and recorded to include the completed building and all of its units as part of the Condominium.
- 5. As each unit in a building was purchased, our office prepared certain closing documents for each transaction, arranged for their execution, and utilized same at closing, after

which they were recorded among the Public Records of Palm Beach County, Florida. The legal descriptions contained in the closing documents were derived from the original Survey prepared by Richard L. Shephard and Associates, Inc., and attached to the Declaration as Exhibit "B".

- 6. After several closings had taken place, from May through October 2000, it was determined that the Unit numbers were incorrectly described in the legal descriptions used in the closing documents, and a Surveyor's Affidavit was prepared and recorded to correct same. The Surveyor's Affidavit, dated October 3, 2000, and recorded October 24, 2000, in Official Records Book 12092, Page 673, of the Public Records of Palm Beach County, Florida, contains the correct parcel number and corresponding Building and Unit numbers, and is attached as Exhibit "A" hereto.
- 7. All of the unit sales and financing documents recorded prior to the Surveyor's Affidavit contained the correct Condominium Parcel, or Lot Number. However, the Unit and Building numbers were either omitted completely or incorrectly stated.
