Article 7 <u>AMENDMENT OF DECLARATION</u>

7.01 Requirements for Amending Declaration

This Declaration may be amended at any regular or special meeting of Unit Owners called or convened in accordance with the Bylaws by the affirmative vote of Unit Owners owning not less than seventy-five percent (75%) of the Units represented at any meeting at which a quorum has been attained. provided however, that in all instances hereunder, irrespective of the quorumachieved, not less than a majority of total voting interests of the "Membership" (as defined in Section 8.01 hereofy shall have voted in connection with such amendment(s). All amendments shall be evidenced by a certificate executed as required by the Condominium Act and recorded among the Public Records of the County; provided, however, that unless otherwise provided in this Declaration:

Sub-Sections A., B., C., and D. of Section 1/01 remain unchanged.
