## THIRD AMENDMENT TO DECLARATION FOR WOODSLANDING

THIS THIRD AMENDMENT TO DECLARATION FOR WOODSLANDING (this "<u>Third Amendment</u>") is made by Avatar Properties Inc., a Florida corporation ("<u>Developer</u>") and joined in by Woodslanding Homeowners Association, Inc., a Florida not-for-profit corporation ("<u>Association</u>").

## RECITALS

- A. That certain Declaration for Woodslanding was recorded in Official Records Book 20052, Page 611, of the Public Records of Palm Beach County, Florida (the "Original Declaration") respecting the residential community known as Woodslanding ("Community"). The Original Declaration was amended by that certain First Amendment to Declaration for Woodslanding recorded in Official Records Book 21794, Page 743 ("First Amendment"); and as further amended by that certain Second Amendment to Declaration for Woodslanding recorded in Official Records Book 22021 at Page 1928, all of the Public Records of Palm Beach County, Florida ("Second Amendment").
- B. Section 5.3 of the Original Declaration provides that prior to and including the Turnover Date (as defined in the Original Declaration), Developer shall have the right to amend the Declaration as it deems appropriate, without the joinder or consent of any person or entity whatsoever. The Turnover Date has not yet occurred.
- C. Developer desires to amend the Original Declaration as set forth herein.

NOW THEREFORE, Developer hereby declares that every portion of the Community is to be held, transferred, sold, conveyed, used and occupied subject to the covenants, conditions and restrictions hereinafter set forth.

- 1. <u>Recitals</u>. The foregoing Recitals are true and correct and are incorporated into and form a part of this Third Amendment.
- 2. <u>Conflicts</u>. In the event that there is a conflict between this Third Amendment and the Original Declaration or First Amendment or Second Amendment, this Third Amendment shall control. Whenever possible, this Third Amendment, the Original Declaration, and the First Amendment and Second Amendment shall be construed as a single document. Except as modified herein, the Original Declaration and the First and Second Amendments shall remain in full force and effect.
- 3. <u>Definitions</u>. All initially capitalized terms not defined herein shall have the meanings set forth in the Original Declaration, except that the defined terms are hereby added or modified as follows:

"<u>Declaration</u>" shall mean the Original Declaration, the First Amendment, the Second Amendment and this Third Amendment, together with all amendments and modifications thereof.

4. <u>Legal Description</u>. Exhibit 1 to the Declaration and Exhibit A to the First Amendment are hereby deleted in their entirety and replaced with the following legal description:

All of the Plat of Woodslanding, according to the plat thereof, as recorded in Plat Book 105 at Page 86, of the Public Records of Palm Beach County, Florida, less and except Lot 1 thereof.

5. <u>Covenant</u>. This Third Amendment shall be a covenant running with the land.
