

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

IMPERIAL ISLE PROPERTY OWNERS' ASSOCIATION, INC.

Articles of Incorporation is amended in its entirety to read as follows (additions to prior language are reflected by underlining, and deletions of prior language are struck through): "Section \{ <u>Duration</u> of Office. Members elected to the Board of Directors by the general membership shall hold office for such periods as are set forth in the By-Laws of the Association. until they resign or until the next succeeding annual meeting of the members, and thereafter until qualified successors are duly elected and taken office." THE FOREGOING AMENDMENT was adopted by majority vote of the Board purpose on the 19th day of 4000, 2005, pursuant to Article VIII of the Articles of Incorporation. The number of votes cast was sufficient for approval, and no vote of the membership was required.
