We look forward to assisting in meeting the requirements of recently passed law **SB-4D**, **known as the Condo Safety Act**, signed into effect by Governor Ron DeSantis on May 26, 2022. The law mandates that a **Milestone Structural Inspection (MSI)** is required by the state of Florida for Condominiums (FL Statute 718) and Co-ops (FL Statute 719) over 3 stories. The qualifying structures must comply with the new standard as defined in the Condo Safety Act by December 31, 2024, in order to remain in compliance.

Additionally, you will also be required to obtain a **Structural Integrity Reserve Study (SIRS)**, a newly developed form of reserve study, also **REQUIRED by the same law**. This advanced reserve study is designed to ensure that condominiums and homeowners associations are reserving funds for crucial structural elements in their buildings for future repairs and replacement. These studies are required to be completed every 10 years to remain in compliance. This time clock is measured from the first certificate of occupancy and annual budgets must include accounting for these structural elements' repairs reserves.





**Common Elements That Make Up the Structural Integrity Reserve Study (SIRS)** 

- 1. Roofing Systems
- 2. Structure, including foundation, floors, and Load Bearing Walls
- 3. Fireproofing & Fire Safety
- 4. Exterior Painting & Water Proofing
- 5. Plumbing Systems
- 6. Electrical Systems
- 7. HVAC Systems
- 8. Windows and Exterior Doors
- 9. Pavements
- 10. Other elements over \$10,000 that have an impact on the structural integrity of the building, such as handrails, elevators, swimming pools, seawalls, docks, water features, etc.

The scope of work includes:

- 1. Phase 1 "MILESTONE STRUCTURAL INSPECTION" of all 3-story buildings.
- "STRUCTURAL INTEGRITY RESERVE STUDY," including inspection of all components and systems with a value of over \$10,000, for ALL association structures and site common elements.
- 3. Visual Inspection of the subject property components as required and dictated by the governing municipality.
- 4. The Allied Milestone Structural Inspection (MSI) Phase One report and Structural Integrity Reserve Study (SIRS) prepared and qualified by a licensed architect or engineer authorized to practice in Florida.
- 5. The licensed architect or engineer and team shall review the visual examination of habitable and uninhabitable areas of a building, including the major components of a building.
- If the architect or engineer finds no signs of substantial structural deterioration to any building components under visual examination in this Phase One Inspection, No Phase Two Inspection will be required.
- 7. Access is required to the inside of the structure, all units, and mechanical rooms at the time of our inspection.
- 8. The Milestone Structural Inspection (MSI) Report will be submitted to the ordering party and to the governing municipality. The Structural Integrity Reserve Study (SIRS) report will be submitted to the ordering party.
