FIRST AMENDMENT TO DECLARATION OF COVENANTS, RESTRICTIONS AND EASEMENTS FOR SATURNIA ISLES

This instrument ("Amendment") is made as of the 1st day of March, 2002 by G.L. HOMES OF BOCA RATON ASSOCIATES IV, LTD., a Florida limited partnership ("Declarant"), whose principal office is located at 1401 University Drive, Suite 200, Coral Springs, Florida 33071-6039, and joined in by SATURNIA ISLES HOMEOWNERS ASSOCIATION, INC., a Florida corporation not-for-profit ("Association"), whose principal office is located at 1401 University Drive, Suite 200, Coral Springs, Florida 33071-6039.

WHEREAS, Declarant has executed and recorded in Official Records Book 13315, Page 1346 of the Public Records of Palm Beach County, Florida, a certain "Declaration of Covenants, Restrictions and Easements for Saturnia Isles" (hereinafter referred to as the "Declaration"); and

WHEREAS, the Declaration provides in Article XIII, Section 8, Paragraph 1 that prior to the "Turnover Date" Declarant may amend the Declaration without the requirement of the consent of the Association or the "Owners" so long as such amendment does not materially impair the common plan of development of "Saturnia Isles" (as such terms are defined in the Declaration); and

WHEREAS, Article XIII, Section 8, Paragraph 1 of the Declaration also provides that the Association shall, upon the request of the Declarant, join in any such amendment; and

WHEREAS, Declarant requests the joinder and consent of the Association; and

WHEREAS, the Turnover Date has not occurred as of the date first above written; and

WHEREAS, the change to the Declaration set forth in this Amendment does not materially impair the common plan of development of Saturnia Isles;

NOW, THEREFORE, Declarant hereby declares that the Declaration is hereby amended as follows:

- 1. The recitations set forth herein are true and correct and are incorporated herein by reference. Unless otherwise defined herein, each term defined in the Declaration and used herein shall have its meaning as defined in the Declaration.
- 2. The following is hereby added after the first sentence of the second paragraph of Article XIII, Section 10:

"Any Owner may petition the Circuit Court for the appointment of a Receiver to manage the affairs of the Association in the event of dissolution of the Association."

- 3. This Amendment shall become effective upon recording amongst the Public Records of Palm Beach County, Florida.
- 4. As modified hereby, the Declaration shall remain in full force and effect in accordance with the terms thereof.
