WHEREAS, the Amendment set forth herein is for the purpose of amending the Declaration of Condominium of Bridgepointe.

WHEREAS, the amendment set forth does not materially effect a unit owners share of the common elements nor impair or prejudice the rights and priorities of lienors or mortgagees.

NOW, THEREFORE, Declarant makes this Amendment to the Declaration as follows:

- I. This Amendment hereby amends <u>Section 20 (b) second paragraph</u>, of the Declaration of Condominium of BRIDGEPOINTE, as follows:
 - "The company or companies with whom the Association shall place its insurance coverage, as provided in this Declaration, must be good responsible companies. authorized and/or non-admitted to do business in the State of Florida. Insurance shall be obtained from Best "A" (or better) rated companies."
- II. Except as amended and modified herein, all other terms and conditions of the Declaration of Condominium of Bridgepointe shall remain in full force and effect according to their terms.
- III. This Amendment has been proposed and adopted by not less than sixty percent (60%) of the Board of Directors and by not less than two-thirds (2/3) of the voting interest of the entire membership of the Association.
