## AMENDMENT TO THE DECLARATION OF CONDOMINIUM OF THE FOUNTAINS OF PALM BEACH CONDOMINIUM NO. 2

As recorded in Official Record Book 2022, Page 911 Public Records of Palm Beach County, Florida

As used herein (unless substantially reworded), the following shall apply:

## **DECLARATION OF CONDOMINIUM**

Amendment to: Article XI. PROVISIONS RELATING TO SALE OR RENTAL OR OTHER ALIENATION OR MORTGAGING OF CONDOMINIUM UNITS: A. Sale or Rental of Units.

Paragraph added: Upon leasing a Unit, the lessee shall have a credit rating score of 700 or higher. Upon purchasing a Unit, the purchaser shall have a credit rating score of 700 or higher at the time the Unit is purchased. Failure of a lessee or purchaser to have the required credit rating score at the time of entering into the lease or at the time of purchase of the Unit, shall be grounds for the Association to disapprove the lease or sale of the Unit.

Amendment to: Article XI. PROVISIONS RELATING TO SALE OR RENTAL OR OTHER ALIENATION OR MORTGAGING OF CONDOMINIUM UNITS: A. Sale or Rental of Units.

Paragraph added: A prospective lessee is required to place a security deposit, the equivalent of one month's rent, not to exceed \$700, into an escrow account maintained by the association. The security deposit shall protect against damages to the common elements or association property. Payment of interest, claims against the deposit, refunds, and disputes under this paragraph shall be handled in the same fashion as provided in Part II of Chapter 83 of the Florida Statutes.
