**CERTIFICATE OF AMENDMENT TO THE TENNIS COURT RULES FOR THE
PRESERVE OF BOCA RATON HOA**

WHEREAS, the amended Tennis Court Rules for the Preserve at Boca Raton set forth were approved by not less than a majority of the Board members present at the meeting.

NOW, THEREFORE, the undersigned hereby certify that the attached Exhibit "A" reflects a true and correct copy of the Tennis Court Rules for the Preserve at Boca Raton as approved by the Board on September 20, 2022.

Except as amended and modified herein, all other terms and conditions of the Association's governing documents shall remain unchanged and in full force and effect according to their terms.

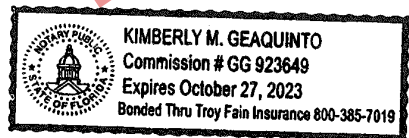

Tennis Court Rules for The Preserve of Boca Raton HOA

1. Courts need to be reserved via the booking system or at the Pro Shop prior to playing
2. Guests must check-in the Pro Shop
3. No outside coaches allowed
4. Non-residents / guests are only permitted to play on the courts with a resident
5. Do not play if the courts are wet. The Preserve Tennis Pro has final say on the conditions of the courts
6. One court per household, unless courts are open and a resident must be playing on each court
7. Court 4 is a designated Teaching Pro court
8. Court priority is given to tennis clinics with one court available for residents not involved in the clinic
9. Proper tennis attire and tennis shoes required at all times
10. No pets, skateboards, bicycles, remote toy vehicles allowed on courts
11. No loud or abusive language
12. No smoking on the courts
13. Court maintenance is to only be performed by Tennis Pro or his staff

Court hours of operation are between 7:30am - 12:00pm and 2:00pm - 10:00pm

Court closed for watering between 12:00pm – 2:00pm
