## TERMINATION OF JOINT OPERATING AGREEMENT FOR BERMUDA ISLES AT BOCA RIO AND CYPRESS LAKES AT BOCA RIO

THIS TERMINATION OF JOINT OPERATING AGREEMENT FOR BERMUDA ISLES AT BOCA RIO AND CYPRESS LAKES AT BOCA RIO (this "<u>Termination</u>") is made by BERMUDA ISLES AT BOCA RIO HOMEOWNERS ASSOCIATION, INC., a Florida notfor-profit corporation ("<u>Bermuda Isles Association</u>") and joined in by CYPRESS LAKES AT BOCA RIO HOMEOWNERS ASSOCIATION, INC., a Florida not-for-profit corporation ("<u>Cypress Lakes Association</u>")



A. That certain Joint Operating Agreement for Bermuda Isles at Boca Rio and Cypress Lakes at Boca was recorded in Official Records Book 19532 at Page 005 in the Public Records of Palm Beach County, Florida (the "Operating Agreement").

B. Paragraph 3.1 of the Operating Agreement provides that Bermuda Isles Association and Cypress Lakes Association agree to combine their operations and management obligations under the Bermuda Isles Documents and the Cypress Lakes Documents by forming the Operations Committee.

C. Paragraph 3.1 of the Operating Agreement further provides that all decisions of the Operations Committee shall be binding upon the Bermuda Isles Association and the Cypress Lakes Association, and that the Bermuda Isles Association shall take all actions and perform all duties required under the Cypress Lakes Declaration that would otherwise be performed by the Cypress Lakes Association. The same paragraph also provides that although the Cypress Lakes Association shall remain in existence, it shall not perform any duties or take any actions until such time as this Operating Agreement is terminated.

D. Paragraph 13 of the Operating Agreement provides that the Operating Agreement can be amended or terminated at any time by two-thirds (2/3) vote of the Operations Committee; provided, however, that any such amendment or termination shall not be effective until it is recorded in the Public Records.

E. The Operations Committee, as reflected in the minutes of the Operations Committee, unanimously voted to terminate the Operating Agreement.

F. The Operations Committee now desires to terminate the Operating Agreement in accordance with Paragraph 13 thereof by instructing Bermuda Isles Association to terminate the Operating Agreement.

NOW THEREFORE, Bermuda Isles Association, pursuant to the direction of the Operations Committee, hereby declares that every portion of the Bermuda/Cypress Community (as defined in the Operating Agreement) is to be held, transferred, sold, conveyed, used and occupied subject to the covenants, conditions and restrictions hereinafter set forth.

1. <u>Recitals</u>. The foregoing Recitals are true and correct and are incorporated into and form a part of this Termination.
