Community Rules and Regulations

Are there parking restrictions in Las Brisas?

Yes. Parking is prohibited on:

Any landscaped portion of the road system, including cul-de-sacs,

Internal roadways except for termporary parking to accommodate guests, and is restricted to one side of the road,

Internal roads for maintenance purposes.

Also, vehicles cannot block sidewalks.

In addition, The Declaration of Covenants, Conditions and Restrictions for Coral Bay specifically provides that no motor vehicle of any type may be parked on any unpaved portion of the common properties. Illegally parked vehicles will be towed at the owner's expense.

The following text has been added to the existing Rules and Regulations:

<u>Vehicles may only be parked on driveways or in garages with the garage door closed. Vehicles may not be parked on the yards of lots.</u>
