4. The swimming pool area must remain open to all community members and access to restrooms must remain available at all times. Swim at your own risk.
5. Glass and alcoholic containers and other breakable items are not allowed in or around the pool area.
6. Children must not use the pool without an adult resident in attendance.
7. Regularly scheduled and Association events have precedence over non-scheduled (reserved) events.
