EXHIBIT "A"
AMENDMENT TO THE DECLARATION OF CONDOMINIUM OF GLENEAGLES CONDOMINIUM V

The original Declaration of Condominium of Gleneagles Condominium V ("Declaration") is recorded in Official Record Book 4992, Page 1427, of the Public Records of Palm Beach County, Florida.

As indicated below, words underlined are added and words ~~struck through~~ are deleted.

Article XV(B) of the Declaration is amended to read as follows:

ARTICLE XV(B) LEASES AND TENANTS

B. Each and every time an Owner leases his Unit, he shall give written notice of such leases to the Association together with the name and address of the lessee and such other information as Association may reasonably require on forms that are supplied by the Association.

No owner may lease his Unit for a term of less than three (3) months, or for a term of more than (1) year. An Owner may only lease his Unit once in any twelve (12) month period. No unit owner may lease his unit more than once in any twelve (12) month period, except to immediate family I.E., father, mother, son, daughter, grandparents.

~~No lessee may lease a Unit in the Condominium or any Gleneagles residence more than once in his lifetime. No owner may lease his Unit for a term of less than three (3) months or longer than (1) year.~~
