2. Residents re-register for each replacement vehicle(s).
3. Parking decals are not and will not be issued to visitors or vendors.
4. Tenant parking decals expire upon end date of lease. Should the lease be renewed or amended, a renewed lease or lease amendment must be provided along with the above credentials to extend/change the end date of the parking decal.
5. TOWING POLICY: Items listed below are subject to tow, vehicles will receive 1 warning before vehicle is towed:
 - a. At any time, a vehicle is parked in the "No Parking" area, blocking access, parking on grass etc.
 - b. Unauthorized vehicles: commercial vehicles, RV's, boats, campers, trailers etc.
 - c. Any vehicle that is not "street legal" including flat tire, expired tag, etc.
 - d. Tenants with expired leases.
 - e. Vehicles without a decal or guest pass for overnight guests.
